

**YOU WORK, I'LL PLAY (YWIP)  
Boarding Client Agreement**

**Please read and initial each statement below:**

\_\_\_ The following major holidays require a 50% deposit due when a boarding reservation is made: Easter, Thanksgiving, Christmas, and New Year's. This deposit will be refunded *only* if the cancellation is made 21 days in advance. **If the appointment is cancelled less than 21 days in advance, the deposit will NOT be refunded.**

\_\_\_ For government holidays such as Memorial Day, July 4<sup>th</sup>, Labor Day, etc. a one-night deposit is due when a boarding reservation is made. This deposit will be refunded *only* if the cancellation is made at least 72 hours in advance. **If the appointment is cancelled less than 72 hours in advance, the deposit will NOT be refunded.**

\_\_\_ I understand that dogs unfamiliar with YWIP may experience separation anxiety.

\_\_\_ I acknowledge that the YWIP boarding facilities house the boarding dogs in open-topped runs with six (6) foot walls and/or fences and certify that to my knowledge, my dog(s) is/are unable to climb such an enclosure.

\_\_\_ I understand that boarding dogs are not supervised at all times.

\_\_\_ I understand that any behavior deemed dangerous or inappropriate may result in dismissal.

\_\_\_ I understand and agree that in admitting my dog(s) into YWIP, YWIP has relied on my representation that my dog(s) has/have not harmed or shown aggressive or threatening behavior toward any person.

\_\_\_ I certify that my dog(s) is/are in good health and has/have not been ill with any communicable disease within the last 60 days.

\_\_\_ I agree to pay for all services due at the time rendered. I understand any unpaid fees by me will be sent to collections and I will be responsible for all collections and legal fees incurred by such actions taken.

\_\_\_ I understand YWIP staff give all pets involved in any type of incident a cursory examination; however, YWIP is not liable for the location, treatment, or diagnosis of any injuries incurred on YWIP premises.

\_\_\_ I have read and understand the YWIP "Rules and Regulations."

I understand that YWIP will make every effort to contact me; however, should any medical emergency arise and I am unreachable, it is agreed that YWIP or its selected agents can and will make any needed decision concerning medical treatment and choice of caregiver up to \$ \_\_\_\_\_.
